Cookies and Tracking Technologies

We use cookies and similar technologies to monitor and enhance your experience. Types include:

- Necessary Cookies: Enable essential website features.
- Preference Cookies: Remember your settings.
- Analytics Cookies: Help us understand how the site is used.
- Session and Persistent Cookies: Depending on whether they are deleted after browsing or stored.

Use of Your Personal Data

We use your personal data to:

- Provide and maintain our services
